This Membership Agreement is made between Secure@Home, an initiative of Jewish Family & Children's Service of Greater Mercer County, a 501(c)(3) corporation, and _____, Member(s).

Secure@Home is a membership-based community program designed to enable seniors to live in their homes while receiving a high level of services to maintain their style of living.

Annual membership fees are \$350 for an individual / \$400 per couple. There is a one-time processing fee of \$30 for an individual / \$50 per couple. Those who join the program while in the midst of a healthcare crisis and need emergency care management will be required to pay a one-time \$75 crisis administration fee.

Membership will begin the date of the initial assessment, and will continue for the next 12 consecutive months. A member of Secure@Home is entitled to all of the benefits of membership contained in the Membership Package which may be amended periodically by Secure@Home.

In order for Secure@Home to monitor its members' needs and levels of service, Member(s) hereby authorize third-party providers to share Member's/Members' non-medical information with Secure@Home about services Members use.

Secure@Home reserves the right to contact Members' listed contacts where Secure@Home identifies health or safety concerns of Members.

Secure@Home will not share any financial, medical or other personal information about any of its Members with any other persons or organizations, except to contact medical professionals you identify and specifically authorize Secure@Home to contact via a signed health information release form.

I realize that Secure@Home makes service provider referrals based on the best information available to it, and is not responsible for the quality of the goods or services provided by any of the referred-to providers. By becoming a Secure@Home Member, I hereby:
