Enclosed is the form needed if you wish to apply to the Hebrew Free Loan Society of Princeton/Mercer/Bucks for an interest-free loan. The document is self-explanatory. Please be sure that each section is completed before the application is returned to us.

For your guidance, the parameters for loans are as follows:

- * Maximum individual loan-- \$3,000.

- * Loans up to \$1,800 must be repaid within 18 months of the loan date. Loans above \$1,800 must be repaid within three years of the loan date.

- * The maximum waiting period before loan repayment begins is 60 days.

- * You must live in the area served by the Jewish Family & Children's Service of Princeton Mercer Bucks.

During the application process, every attempt will be made to structure a loan that will work for you.
